

Fixed Price Veterinary Fee Package 2021 Season

Fresh and Chilled Semen

For mares' resident at **Brendon Stud** a fixed price package per cycle is available.

This includes:

- Pre-breeding examination and evaluation.
- Communication with stallion owner or semen agent regarding semen shipment.
- Prostaglandin to induce oestrus.
- Any swabs and smears deemed necessary at the pre-breeding examination.
- Unlimited examinations using ultrasound to identify the optimum time for insemination.
- The visits to the stud required to perform the examinations.
- The use of ovulation agent to induce ovulation.
- Insemination.
- Evaluation of the semen supplied.
- Examination after insemination to check for ovulation and post inseminating problems.
- Oxytocin injections if required.
- Caslicks procedure to improve vulva seal.
- Squeezing of twins or follow up examination.
- The first 14 and 16 days pregnancy scans.

The package does not include:

- Any biopsies deemed necessary at the pre-breeding examination.
- Sedation if deemed necessary for the safety of personnel and the mare.
- 28 and 42 day ultrasound pregnancy scans.
- Any treatment (intrauterine antibiotics or saline lavage) required to treat uterine inflammation pre or post inseminating.
- Treatment of any condition not associated directly with breeding of the mare or foal at foot.

The fee is £360 + VAT for the first cycle and if the mare does not become pregnant subsequent cycles will be charged at £260 + VAT.

All efforts are made to contact owners to obtain approval of non-stud medicine related treatment, however, should an emergency arise necessitating treatment of the mare or foal at foot then this will be done after consultation with the stud owner/manager. The practice reserves the right to perform procedures or treatment deemed necessary to ensure animal welfare.
